Our trading desk executes across forex, gold, and cryptocurrency markets, processing more than 1,500 lots per day and delivering consistent returns through proven strategies and disciplined risk management.

Building on this success, we've launched the VFX Token — a utility-driven digital asset that bridges traditional finance and Web3. VFX Token holders gain access to zero-fee premium trading accounts, staking rewards, income from real-world trading rebates, exclusive payment cards, and governance rights within the ecosystem.

By combining the stability and compliance of a regulated trading firm with the scalability and transparency of blockchain, Vortex FX and VFX Token create a unique, sustainable pathway for investors to participate in both traditional markets and decentralised finance.

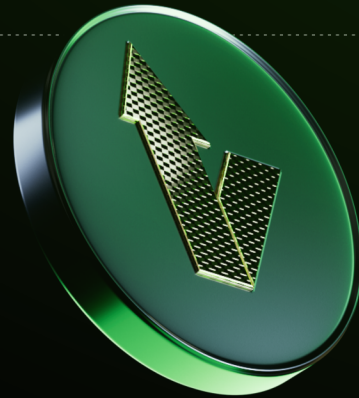

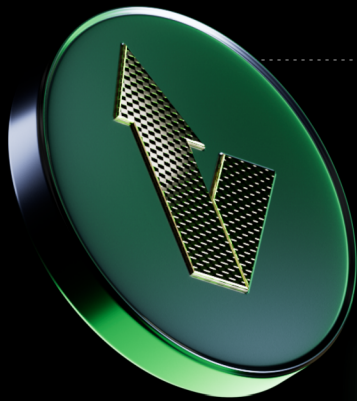

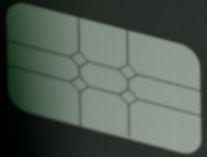

Trading 300+ lots per day with \$1 million AUM generates approximately \$45,000 monthly in rebates (\$7.50 per lot, 20 trading days). Half of these rebates (\$22,500) fund market buybacks, supplemented by Web2 profits, with tokens vaulted or redistributed via smart contracts.

Technology: AI-driven trading with real-time market scanning, deep learning, and Meta-Trader 5 integration ensures low-latency execution (sub-40ms, 0.0 pip spreads).

4.2 Platform Features

The VFX platform offers robust features to enhance investor experience: **Execution:** Institutional-grade infrastructure via NY4/LD5 data centers.

Accessibility: Zero commission deposits and withdrawals via Visa, Mastercard, PayPal, Neteller, Skrill, and bank transfers.

VFX Card: A Web3-powered Visa/Mastercard for spending staking rewards.

1,500 cards at \$299 each. Equivalent tokens (e.g., 4,485,000 at \$0.10 or 8,970,000 at

\$0.05) are burned, reducing supply and boosting APY

: Customizable risk profiles for steady or aggressive returns.

Staking Yield: The 67.7% APY is the maximum projected for a 365-day staking period, driven by buybacks funded by Web2 profits and token burning via VFX Cards, supported by the 10 million token staking pool.



Partnerships: VFX Token is supported by strategic partnerships with leading exchanges and platforms, including DEXScreener, providing real-time analytics and market visibility, MEXC, delivering global trading access and liquidity, Bitget, offering advanced trading tools and a wide user base, and KuCoin, one of the most trusted exchanges ensuring accessibility and credibility. Together, these partners strengthen VFX Token's ecosystem and expand its reach to investors worldwide.

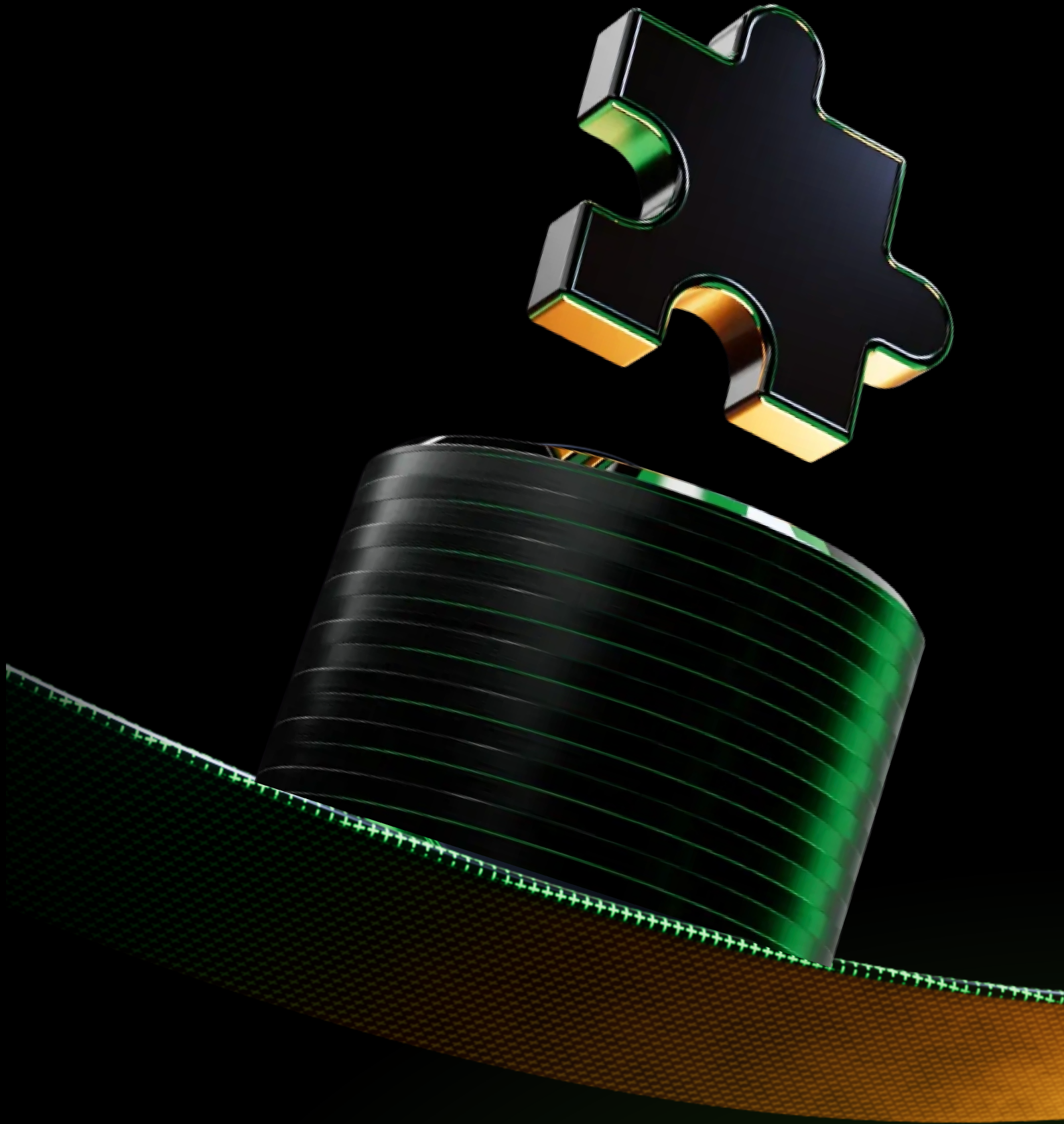

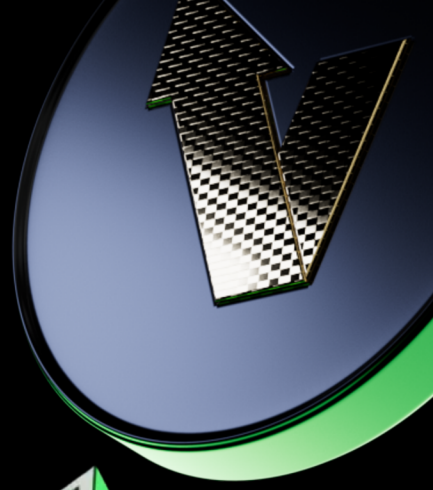
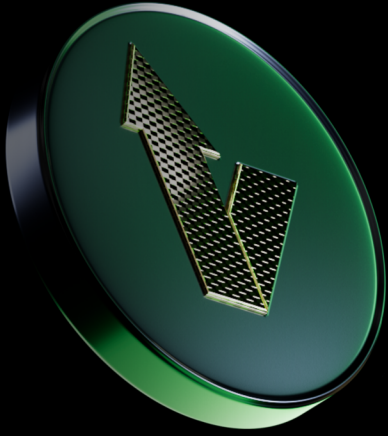
